# Overview of what other Student Unions are doing in relation to student sex work

Note – the vast majority of activity has been from student unions with some universities discussing more formal approaches (York, Goldsmiths) but currently (May 2020) there is no official university policy on student sex work.

University of York Student Union passed a policy in 2017 which aimed at:

- 1. Supporting sex workers by raising awareness.
- 2. Offering advice and information.

1. To support sex worker led organisations, such as the ECP, SWARM etc.

2. Campaign against any attempt to introduce the Nordic Model in the UK.

3. Support student sex workers being threatened with disciplinary action owing to their status as a sex worker.

4. Support sex workers who are victims of discrimination, harassment in the university.

Goldsmiths University Student Union introduced a policy in 2015 which outlines the unions commitment to:

- 1. Support the full decriminalisation of sex work.
- 2. Resist and campaign against proposals to introduce the Nordic Model in the UK.
- 3. Provide students with information about where they can seek help.
- 4. Support the efforts of sex worker-led organisations.

1. Support and campaign for the decriminalisation of sex work.

2. Campaign against any attempt to introduce the Nordic Model to the UK.

- 4. Challenge any disciplinary action taken against student sex workers on the basis of their job.
- 5. Listen to and include student sex workers as part of the student community.

1. Supporting the decriminalisation of sex work.

- 2. Supporting sex worker-led organisations.
- 3. Campaigning against the introduction of the Nordic Model in the UK.

What will we do?

1. EUSA will put out a statement calling for the decriminalisation of sex work.

2. EUSA will contact sex workers' rights organisations such as SCOT-PEP and Sex Workers' Open University and offer their support.

3. EUSA will take a zero-tolerance attitude towards whorephobia, and place whorephobia in its safe space policy.

- 4. EUSA will explore what support it can offer the university's student sex workers.
- 5. EUSA will condemn anti-sex worker campaigns at other universities.

This will enable you to receive warnings about dangerous individuals, and lets you check numbers against a database of reported dangerous individuals. Ugly Mugs can also help you file a complaint and report incidents to the police anonymously.

<u>http://www.saafe.info/main/index.php</u> - The SAAFE forum also allows you to search for reported numbers. Input the number into the search box with an asterisk replacing the last two digits, e.g. 012345678\*\*. As well as this, the forum is a place where you can seek support and advice related mainly to indoors escorting. There is also a section for webcam workers.
