

### 1. Aim

In line with Health Education England's Values-based Recruitment Framework, <a href="https://www.hee.nhs.uk/our-work/values-based-recruitment">https://www.hee.nhs.uk/our-work/values-based-recruitment</a>, the aim of Leicester Medical School is to have a selection process that is open, objective and fair. This is in order to select students with the academic ability, character and values to become caring, competent, compassionate, effective and safe doctors as set out in the Leicester Medical School Code of Practice for Management of the MB ChB (Bachelor of Medicine and Bachelor of Surgery) Curriculum. This policy document sets out the Medical School's selection procedure and will be reviewed annually.

### 2. Governance

The Lead for Medical Admissions, or one of the other Admission Tutors, will chair an Admissions Group which will meet at least twice a year and report to the School Education Committee. The Admissions Group will:

- Ensure that the Medical School publishes information about admissions procedures, including guidance about the selection process and the basis upon which places will be offered.
- Ensure that selection criteria and processes take account of the personal and academic
  qualities and values needed in a doctor as set out by the General Medical Council (GMC)
  and the National Health Service (NHS) constitution, as well as the capacity to achieve the
  academic and practical skills outcomes for medical graduates described by the
  <a href="https://www.gmc-uk.org/education/standards-guidance-and-curricula">https://www.gmc-uk.org/education/standards-guidance-and-curricula</a> and therefore
  successful registration by the GMC.
- Review, through membership of the Medical Schools' Council (MSC) Selection
   Alliance, the latest evidence regarding academic qualifications, selection tests and selection processes.
- Ensure, through collaboration with the Medical School's Assessment team, that the selection procedures adopted are valid, reliable and fair.
- Ensure that the selection process includes individuals with a wide range of expertise and knowledge, including patient/carer and student representation.
- Ensure that those involved in selection are trained to follow current Equality, Diversity and Inclusion legislation and good practice (University of Leicester Equality, Diversity and Inclusion Team).
- Work with the central University to ensure the smooth operation of selection and recruitment; and that the Universities Senate Regulations are upheld (Senate Regulation 2: Regulations governing admissions and registration for taught programmes).
- Put into place and manage mechanisms to deal with queries or complaints from applicants/ potential applicants.
- Work with the University to ensure that the number of applicants recruited in specified categories is consistent with the externally (Office for Students) set quotas.
- Work with the University widening participation and recruitment teams, as well as
   UKWPMED (UK Widening Participation in Medicine a collaboration of seven UK
   medical schools), to monitor recruitment from under-represented groups and explore
   ways of enhancing recruitment from these groups through e.g. contextual offers.



### 3. Selection

The Medical School offers a five-year MB ChB course (A100) and a six-year MB ChB with a Foundation Year course (A199).

Our aim is to select students who possess the academic ability and personal qualities required for the study and practice of medicine. All applications for the **A100** and **A199** courses must be made through UCAS (<a href="https://www.ucas.com/">https://www.ucas.com/</a>) and received before the UCAS closing date (15<sup>th</sup> October 2025 for 2026 entry), with the exception of those applying via the UoL (University of Leicester) Internal Transfer route (see Section 17 below). We do not consider late applications but, on occasion, will enter Clearing if we have not filled all our places. The specific entry requirements and full details of the selection procedure are published on the Medical School website (<a href="https://le.ac.uk/study/medicine/entry-requirements">https://le.ac.uk/study/medicine/entry-requirements</a>) in May or June prior to each admissions cycle.

### 3.1 Entry Requirements and Places

#### A100 Five-year MBChB course

For 2026 entry, the number of places on our A100 MBChB course is 293: 275 places are for Home students (to include up to 38 places for students progressing from our A199 course), with 18 places available for International applicants. EU candidates are considered as international students unless they have settled or pre-settled status in the UK.

Fee status informs the selection process, and in recent years it has been more competitive to gain entry as an international student. We will consider candidates who are likely to get Indefinite Leave to Remain (ILR) within one admissions cycle (eg apply October 2025 for registration September 2026) as home candidates, but any offer would be conditional on the ILR. Otherwise, candidates would be assessed as international students and included in the numbers cap.

Full details of our entry requirements and our scoring documents can be found on our website. These are updated annually and published around May or June for the year of application.

All applicants must meet our minimum GCSE requirements in addition to other academic requirements. We will not consider applicants with grades below our minimum entry requirements even if there was mitigation. Equivalent qualifications are considered. There are 5 routes for applying:

- 1) Applications from those with achieved or predicted A-levels (or equivalent). These should normally be completed within 2 years of GCSEs (or equivalent).
- 2) Applications from those with an achieved or a predicted Bachelor with Honours degree or a 4-year integrated Master's degree.
- 3) Applications from mature students with an achieved or a predicted QAA approved Access to Medicine qualification and five years' paid employment, including at least one year in a relevant caring role.



- 4) Successful progression from our standalone International Medicine Foundation Year course A198.
- 5) Internal transfer, via competitive route, from selected other University of Leicester courses. We do not consider transfers from other universities.

All applicants must show evidence of recent academic study (within three years of the UCAS closing date).

Applicants who have started another degree and meet our A-level entry requirements may apply during their FIRST year, otherwise they will need to be in their final year or have completed their degree. We will not consider applicants in the second or penultimate year of any degree course.

#### A199 Six Year MBChB course

The A199 Medicine with a Foundation Year (6 Year) course began as a local initiative to widen access to Medicine from under-represented groups in the East Midlands. For 2026 entry, there are 38 places; up to 15 of those will be reserved for applicants residing in the East Midlands. All applicants must meet the widening access criteria as published on the Medical School website: https://le.ac.uk/study/medicine/entry-requirements/foundation

International students are **not** eligible to apply. Applicants must be UK students who are studying in the UK.

All applicants must also be within 2 years of leaving school at time of UCAS closing date. Candidates who have started another degree course will **not** be considered, even in the first year of that course.

### 3.2 UCAT

All applicants for both A100 and A199 must take the UCAT (University Clinical Aptitude Test, <a href="https://www.ucat.ac.uk/">https://www.ucat.ac.uk/</a>) in the year of application. UCAT does not offer exemptions but can offer a number of access arrangements, including extra time and rest breaks. Further information can be found at <a href="https://www.ucat.ac.uk/register/access-arrangements/">https://www.ucat.ac.uk/register/access-arrangements/</a>.

If an applicant is unable to take the test due to illness or personal circumstances, decisions regarding whether to consider an application will be made by the Admissions Tutors following receipt of all required evidence. However, given the duration of the testing period, it is highly unlikely that an application without a test will be considered.

UCAT provides a bursary scheme for those who receive benefits due to a low household income. Medical schools are provided with this information. Having a UCAT bursary may be used with other contextual data, as stated in Section 6 below.

The total UCAT score is used in combination with prior academic attainment to generate a score to rank candidates for interview.

Candidates with SJT Band 4 will not be considered further. Details of the scoring procedure for the University of Leicester

A100 and A199 courses are made available in separate documents on the Medical School Website.

### 3.3 Personal Statement & Academic Reference

The personal statement is not routinely used in selection for interview but is used for refinement of the ranking for borderline candidates either prior to interview and/or when making an offer.

Predicted grades (including degree classifications) must be stated in the academic qualification part of the UCAS form and not in the reference. We cannot guarantee that predicted grades will be picked up if they are in the reference.

We ask referees to use the Extenuating Circumstances Section if appropriate for recording significant information such as a candidate being in receipts of free school meals for 6 months or more; having been in the care sector for 3 months or more; being in receipt of 16-19 bursary; or having other significant personal and family circumstances that might have affected academic attainment.

We will not consider evidence here in terms of resits or bonus points. Applicants must have completed a mitigating circumstances form to be considered for these.

### 3.4 International Candidates

18 places are available for International/EU candidates on our A100 course. International/EU candidates are required to apply via UCAS and to sit the UCAT. Exemption is not provided on geographical grounds and applicants are required to travel to their nearest test centre. UCAT provides a Test Centre Locator to enable candidates to locate their nearest test centre.

All academic results will need to be included, for instance if you have studied more than six MYP subjects, you must declare all the results.

If candidates do not have formal year 10/11 examination results (i.e., GCSE/ MYP equivalents), they will need to submit school transcripts at the time of application to medadmis@le.ac.uk.

We will not chase candidates for this information. A reminder will be included in the confirmation of application email candidates are sent.

### 4. Minimum Age

All candidates on either course must be 18 years of age by 1<sup>st</sup> September in the year of enrolment. If a candidate will not be 18, but meets all our other entry requirements, they can still apply. However, if they are made an offer, it would be for deferred entry (usually a year later).

### 5. Mitigating Circumstances

Academic performance may be affected by unforeseen or unpredicted personal circumstances and such circumstances may be taken into account when considering applications. These might include, University of Leicester

but are not restricted to, personal health, health of an immediate family member and domestic issues. Applicants must provide evidence of mitigation with independent corroboration. We will not consider on the basis of personal emails only.

In order to get a decision from our Mitigating Circumstances Panel before the UCAS closing date, all information concerning mitigation must be provided before the **1**<sup>st</sup> **of September** in the year of application; and before the **1**<sup>st</sup> **October** to be considered by the Panel at all.

NB. We will not consider applicants with academic requirements below our minimum, even if we accept their mitigation, but we may accept resits; or consider awarding a maximum of 2 bonus academic points.

### 6. Widening Access and Use of Contextual Data

The A199 course is specifically designed to widen access for candidates from a non-traditional medical applicant background.

Contextual data is used on the A100 course in the following ways:

- a) Candidates who have successfully completed a Realising Opportunities Programme (ROP), or
- b) the UoL AccessLeicester: Medicine, or
- c) a fellow UKWPMED member's progression course may be invited directly to interview if they meet a number of other requirements (see scoring document).

If successful at interview, these candidates will be made an adjusted offer. Applicants must have Home fee status at the point of application to be considered via one of these programmes.

Other applicants who fall into a borderline group (either pre- or post-interview) will also be assessed using their whole UCAS application, UCAT result, as well as the following contextual data:

- Attendance at a non-selective state school for GCSEs which has an Attainment Score 8 below the national average in the relevant year - Department for Education performance tables will be used;
- b) IMD (index of Multiple Deprivation) 1 or 2;
- c) In receipt of Free school meals for at least 6 months or the 16-19 bursary;
- d) In local authority care for at least 3 months;
- e) Refugee status;
- f) In receipt of UCAT Bursary

Candidates who are successful at interview and live in IMD 1 **plus** receive either UCAT bursary; or free school meals over 6 months; or are in receipt of 16-19 bursary, or have been in care for at least 3 months will be made an adjusted offer.

### 7. Specific Learning Difficulties and Disabilities

Candidates with specific learning difficulties or disabilities are welcome to apply. Such candidates will be considered according to the University's Equal Opportunities Policy, taking into account the advisory guidelines published by the GMC in its 'Welcomed and Valued' document. Declaration on the UCAS form does not negatively influence the pre-interview selection process, nor the interview, in any way. In addition, the Medical School may be able to make reasonable adjustments for such



candidates, including at interview.

However, the Medical School must ensure that all candidates will be able to meet the core learning outcomes and practical competencies of the course and, additionally, be able to practise as a doctor on completion of the course. The GMC mandates that, in order to be conferred a medical degree and be registered by the GMC on course completion, doctors must be able to perform a number of practical tasks as listed in GMC's Outcome for Graduates — Practical Skills and Procedures <a href="https://www.gmc-uk.org/education/standards-guidance-and-curricula/standards-and-outcomes/outcomes-for-graduates/outcomes-for-graduates---practical-skills-and-procedures">https://www.gmc-uk.org/education/standards-guidance-and-curricula/standards-and-outcomes-for-graduates/outcomes-for-graduates---practical-skills-and-procedures</a>

A satisfactory Occupational Health screen is therefore a requirement of all offers. Some candidates will also be asked to have a formal Occupational Health assessment to discuss any reasonable adjustment and support mechanisms that should be put in place. Occasionally, this assessment may result in a referral to a Fitness to Practise panel (see Section 13).

#### 8. Interview

In addition to academic ability, applicants should possess those personal qualities required of a good doctor. These include empathy, good communication skills (speaking and listening), good organisational skills, and a caring manner. These qualities will be assessed predominantly at interview. The number of candidates interviewed will be determined prior to each admissions cycle, following a review of the previous year.

A multiple mini-interview format is used and stations will assess different attributes, including:

- Communication Skills
- Problem solving
- Personal qualities and values
- Motivation and suitability
- Ability to show empathy and compassion
- Organisational ability
- Numeracy

These interviews will be face-to-face for Home fee status applicants, and online for International fee status applicants; though we reserve the right to change the interview format if circumstances change.

Each station will be given equal weighting. Candidates are also assigned a global rating (excellent, good, satisfactory or poor). Candidates with a good overall score but poor rating(s) may be asked for a second interview. This is usually a face-to-face panel interview and is usually held on an Offer Holder's Day.

Details of the timing of interviews will be published for each admissions cycle on the Medical School website. They are usually held in December and January so candidates and their families/ friends should take this into consideration when booking holidays etc.

#### 9. Offers

No offers are made without an interview.



The number of offers likely to be made will be determined prior to each admissions cycle following a review of the previous year. Following batches of interviews, some candidates will receive offers, some will be rejected and some will be kept on hold until all interviews have been completed and final decisions have been made by other offer holders by the UCAS decision date in May/June.

Some late offers may be made depending on the conversion rate of offers to firm acceptances. The timing of decisions by applicants is not in our control but this does affect our ability to make final decisions on some other candidates.

Sometimes candidates, who are not holding other medical places, will be asked if they wish to remain on a waiting list after the UCAS deadline for institution decisions has passed. Invitations to be on the wait list will be sent prior to the UCAS candidate decision deadline, since applicants who have accepted a 5<sup>th</sup> choice offer (not medicine) cannot be approached unless they have contacted us to confirm that they wish to be on our list.

All offers are subject to a satisfactory Occupational Health and Disclosure and Barring Service screens. Many will have academic conditions too. Some candidates will be asked to have a formal Occupational Health assessment to discuss any reasonable adjustment and support mechanisms that should be put in place (see Section 7).

Whilst most offers will be based on total interview score compared to applicants in the same group, candidates in a borderline group (e.g., lower score and/or a number of poor global ratings) will be reviewed by the Admissions Tutors along with their UCAS application, contextual data (see Section 6), personal statement and reference.

### 10. Deferrals

Although we are happy to consider applications for deferred entry, and will make deferred offers to candidates who will otherwise be under 18 years of age on September 1<sup>st</sup> of year of entry, we will not consider deferred entry from graduates; nor consider late requests for deferral **after 1st April** in any cycle unless there are significant unforeseen circumstances that have been agreed by the Admissions Tutors.

For candidates who are undertaking mandatory national service for a 2-year period, we will consider 2-year deferral in this situation.

### 11. Equality and Diversity

In addition to specific training about the selection process, all staff involved in selection will receive training in equality, diversity and inclusivity, as well as unconscious bias.

### 12. Criminal Records

Students who have been resident in the UK are required to complete a fully enhanced Disclosure and Barring Service (DBS) check at commencement of the course. Students who are resident in other countries must provide a Certificate of Good Standing from the embassy or local police force. University of Leicester

Potential applicants are advised to contact the Medical School if they have a criminal conviction, caution, reprimand or final warning which is not 'protected' as this may affect their fitness to practise.

The 2013 amendments to the Rehabilitation of Offenders Act 1974 Exceptions Order 1975 means that certain spent convictions are 'protected' and therefore do not need to be declared; others are 'listed offences' and must always be declared. #### 13. Fitness to Practise

It is anticipated that graduates will practise as doctors in the UK and therefore require provisional, then full, registration with the General Medical Council (GMC). Any issues regarding health, disability or criminal conduct that might preclude future registration must therefore be declared at the time of application. Such declarations will not affect the scoring of applications, nor the interview.

However, if at the point of offer the Admissions Tutors consider that a declared issue may impair future fitness to practise, they will refer the applicant to the Fitness to Practise Committee; they will deal with such matters separately from the selection process.

Candidates being considered for an offer will also have their details checked against the Medical Schools' Excluded Students database, following signed consent. No place will be given without receiving this signed consent.

Candidates should also remember that our policy is to recruit in line with Values-Based recruitment as part of the NHS constitution. If a candidate is felt to demonstrate inappropriate behaviour, probity concerns, or inappropriate use of social media at any stage through the whole application process, this may result in a referral to a Fitness to Practise Panel and/or withdrawal of their offer.

### 14. Re-application

We will consider repeat applications in the following circumstances:

- Applicants presenting with achieved or predicted A-levels, IB or equivalent, who have
  applied once before but have not been interviewed, will be considered and scored as usual
  on their second application. Subsequent applications will not be considered without further
  qualification at degree level. Applicants on a second gap year will only be considered with
  evidence of paid experience in a caring role.
- Applicants presenting with an achieved or predicted degree, who have applied once before
  with their degree, but have not been interviewed, will be considered and scored as usual on
  their second application. Subsequent applications will not be considered without evidence
  of substantial paid employment in a caring role.
- Applicants presenting via the Access to Medicine route, who have applied once before but have not been interviewed, will be considered and scored as usual on their second application. Subsequent applications will not be considered without evidence of substantial paid employment in a caring role.

The benefits of a UKWPMED or ROP completion will only apply to candidates currently in year 13, or in their first gap year.

In all cases, applicants who have been rejected following interview will only be considered in the University of Leicester

following year's cycle if their interview score was no more than 5% below the level required to be on our waiting list in the year of application. Since they will be considered to have had prior interview experience, the two interview scores will be averaged.

If a candidate was interviewed as an undergraduate, was not successful and then applies as a graduate, the previous interview score will be disregarded.

UCAT will need to be retaken in every year of application.

Candidates who were invited to interview but failed to attend and did not inform the Medical School as to why, will not be considered again.

### 15. Feedback

Unsuccessful candidates can request feedback on their application. This will normally be in the form of areas of strength and weakness.

Feedback for candidates attending interview but not being made an offer, will not normally be made available until all interviews have taken place and candidates have been informed of the Medical School's decision. We will not release individual station scores, but will give themes for future development.

We will not provide interview feedback to successful candidates.

### 16. Transfers from Other Medical Schools

Applications for transfer from other UK or non-UK medical schools are not considered unless a specific agreement with an institution or government is in place.

Applications from candidates who have previously started a medical degree and have been terminated **will not** be considered.

Applications from those who have voluntarily withdrawn through ill health or circumstances beyond their control will be considered on evaluation of the evidence provided, including references from their previous institution. Such applicants will be expected to begin their studies in year 1 of the MBChB programme, and will be subject to the same entry requirements and application process as all other applicants; i.e., there is no guarantee that they will be selected for interview nor made an offer. We will not consider applicants where there are any unresolved fitness to practise or professionalism concerns, nor any academic progress issues.

### 17. Internal Transfer

A competitive application process, mirroring closely the standard application process, will allow a small number of year 1 University of Leicester students studying Biological Science, any of the Medical Science degrees, Chemistry or Psychology to enter year 1 of the A100 Medicine course.



The following will be taken into consideration:

- First year University academic achievement
- A-level or equivalent qualifications
- UCAT in year of transfer
- Personal statement
- Ongoing commitment to Medicine
- References

The highest scoring candidates will be invited to attend multiple mini-interviews (see Section 8).

If there are no spaces left on A-level Results day, we will not take any transfers; there are no places reserved for transfer students, as these students also count in our number cap.

There is also a competitive transfer route from Clinical Sciences to year 2 of Medicine, which assesses similar criteria to those listed above. Again, there is no guarantee of transferring as there will need to be spaces available on the A100 Medicine course; these transfer students also get counted in our year 1 numbers.

Whilst international applicants can apply for transfer, because of the cap on international students, there may be no international vacancies in the year they wish to apply for.

To apply for transfer, the minimum GCSE requirements for A100 must also be met and there are also minimum A- level (or equivalent) requirements.

#### 18. Review

At the end of each admissions cycle, a review will take place to determine any changes or improvements required for the following cycle.
