Transfers from the degree of Bachelor of Laws with French Law and Language

1. a) Students who have passed first- or second-year examinations for the degree of Bachelor of Laws with French Law and Language may, on giving notice in writing to the Head of School not later than the beginning of the First Semester of the next academic year, transfer to the second or third year of the course for the degree of Bachelor of Laws, as the case may be. If any students give such notice by the beginning of the First Semester, the Head of School may permit them to make the transfer if it is of the opinion that they will be able to take advantage of their proposed course as a whole.

- b) If any students fail only Modern French Language in the first-year or second-year examinations for the degree of Bachelor of Laws with French Law and Language (either at a first attempt or at resit), the Head of School may permit them to transfer to the second or the third year of the course for the degree of Bachelor of Laws, as the case may be, if it is of the opinion that they have shown sufficient evidence of their ability in law to justify the proposed transfer.
- 2. Students who have passed the second-year examinations for the degree of Bachelor of Laws with French Law and Language and who are unable to transfer to the degree of Bachelor of Laws under (1)(a) above, or who are not allowed to proceed to the fourth year of the course for the degree of Bachelor of Laws with French Law and Language because they have not satisfactorily followed the approved courses at a French University, may be permitted to transfer to the third year of the course for the degree of Bachelor of Laws in the First Semester (Autumn Term) of the calendar year after that in which they passed the second-year examinations for the degree of Bachelor of Laws with French Law and Language, but the Board shall not permit them to make the transfer during that semester unless it is of the opinion that they will be able to take advantage of the course as a whole.
- 3. a) Students transferring to the second year of the course for the degree of Bachelor of Laws shall be required to take LW1051 and LW1054 Tort as one of their second-year modules and for this purpose only, Tort shall be deemed to be included in the list of second-year modules and of the papers in second-year examinations for that degree.
 - b) Students transferring to the third year of the course for the degree of Bachelor of Laws shall be credited with the ten credits obtained in Modern French Language 3 and the ten credits obtained in Modern French Language 4 and these credits will be attributed to the Part 1 Final Examination.

LLB LAW WITH A YEAR ABROAD

FIRST, SECOND AND FOURTH YEAR MODULES

As for the first- second- and third-year modules for the degree of Bachelor of Laws.

THIRD YEAR

The third year will be spent abroad either taking approved courses in an institution associated with the School of Law under the SOCRATES student mobility programme, (European institutions), or under the University's Study Abroad programme (institutions outside the European Union). Students will be required to complete the approved courses satisfactorily. Passing examinations in those courses shall be regarded as evidence of the students' having completed them satisfactorily. Students who, in the opinion of the Board of Examiners, have not satisfactorily followed the approved courses at the overseas institution will not normally be allowed to proceed to the fourth year of the course, but may be permitted to transfer to the final year of the course for the degree of Bachelor of Laws.

(N.B. Students may only enter this course by transferring from the degree of Bachelor of Laws, and on the recommendation of the Head of School. Transfer is conditional on successful completion of first-year modules).

Passing the examinations set by the French University shall be regarded as evidence of the students' having satisfactorily followed those courses.

THIRD AND FOURTH YEAR MODULES

Students reading for the Bachelor of Laws/Maîtrise in English and French Law are required to spend two full academic sessions in France following approved courses at the Université de Strasbourg).

Successful students will graduate with the degree of Bachelor of Laws from the University of Leicester and a Maîtrise from the Université de Strasbourg). To be awarded the degrees students must satisfactorily complete all four years of the degree programme.

Transfers from the Bachelor of Laws/Maîtrise in English and French Law

- Students who have passed first- or second-year examinations for the degrees of Bachelor of Laws/Maîtrise in
 English and French Law may, in exceptional circumstances, on the approval of the Head of School, transfer to
 the second or third year of the course for the degree of Bachelor of Laws in Law at the University of Leicester, as
 the case may be. Students will not be allowed to transfer to the degree of Bachelor of Laws with French Law and
 Language.
- 2. Students who have failed third- or fourth-year examinations for the degrees of Bachelor of Laws/Maîtrise in English and French Law may, in exceptional circumstances, on the approval of the Head of School, transfer to the third year of the course for the degree of Bachelor of Laws in Law at the University of Leicester. Students will not be allowed to transfer to the degree of Bachelor of Laws with French Law and Language.
- 3. Students permitted under paragraph 1 or 2 above to transfer from the Bachelor of Laws/Maîtrise in English and French Law to the degree of Bachelor of Laws will be subject to the scheme of assessment for that degree.

LLB SENIOR STATUS

FIRST AND SECOND YEAR MODULES

Note: Students are only permitted to enter this degree with a first or second class honours degree, or their equivalent in a first degree in any discipline.

Transfers from the Bachelor of Laws Senior Status Degree

- Students who have passed the first year examinations for the degree of Bachelor of Laws Senior Status in Law
 may, in exceptional circumstances, on the approval of the Head of School transfer into the second year of the
 course for the degree of Bachelor of Laws in Law at the University of Leicester.
- 2. Students permitted under paragraph 1 to transfer from the LL.B. Senior Status to the degree of Bachelor of Laws will be subject to the scheme of assessment for that degree.
