

Adapted rooms policy

The University of Leicester is committed to make reasonable adjustments to support individuals who, due to disability, a long-term medical condition require adapted accommodation or a particular location to help them participate fully and enjoy a fulfilling university experience.

We are committed to:

- equal opportunities;
- making residences accessible to all;
- welcoming and supporting disabled students.

Prospective students and current students should contact the AccessAbility Team to discuss their accommodation requirements and should be aware that medical evidence is required to support all accommodation requests for adapted rooms. The requirements are listed below:

- contain a confirmation of the disability or medical condition stated on your application;
- signed by a doctor or other medical professional;
- printed on headed paper.

AccessAbility can't accept medical evidence that:

- has been provided by a family member;
- is not in it's original format.

We have a limited number of adapted and accessible rooms so students should apply as early as possible for their accommodation and contact AccessAbility Team (accessable@le.ac.uk) to discuss arrangements so that any reasonable adjustments can be implemented before a student arrives. Available rooms will be allocated on a first come first served basis. Below is a breakdown of the application process for both prospective and current students.

Request for adapted accommodation

The deadline for completion of applications to guarantee accommodation in your first year of study at the University is 1st September though we encourage the application to be submitted at the earliest opportunity.

The deadline for completion of applications to guarantee accessible accommodation for returning students is 30th June. Applications after this period may not be offered a room which meets their specific requirements.

When completing your request for accommodation, please think carefully about

how your accommodation can help you manage your health condition or disability. The following are examples of indicative adjustments and equipment that could be added to the details of your request.

- Accessible parking near the accommodation
- Ground floor accommodation
- Accommodation with a lift
- Wheelchair accessible accommodation
- Automatic doors to the flat and room
- Hoist (either fixed or mobile)
- An ensuite bathroom
- Adapted bathroom/toilet (shower seat, grab rails, height adjusted facilities)
- Alarm pull cords in the bedroom and/or the bathroom

- A kitchen with height adjustable facilities
- Deaf Guard pillow
- Flashing fire alarm
- A fridge in the room
- Space for specialised furniture
- A carer's living space
- Facilities for a guide/assistance dog trained with an organisation such as Guide Dogs UK or Assistance Dogs International

The adapted rooms usually have a larger bathroom than other rooms. Further information can be found on our accommodation webpages, such as bed sizes. Special facilities requested, such as a vibrating pillow for those with impaired hearing, will be issued to residents who require them for health and safety purposes.

We will try to match individuals to suitable accommodation but if further adaptations are required these can be arranged. However, we ask students to visit or engage in fuller discussions well in advance so that the University can make reasonable adjustments in a timely and appropriate manner. We ask for early engagement otherwise we cannot guarantee that your requirements will be met by the time you begin your course.

Bringing your specialist furniture or equipment with you

Should a student wish to bring specialist equipment or furniture with them, an occupational therapist assessment report should be provided to AccessAbility by 1st September. This will help ensure that we can provide the student with the best adapted room to meet their needs.

If you require a guide/assistance dog during your stay, you must notify the accommodation team by emailing prior to the arrival date of your contract.

Room subsidy

Students who might incur additional costs for en-suite, studio or flat accommodation as a direct result of a disability may be eligible for a subsidy towards these costs on disability grounds. The subsidy is offered by the University of Leicester and is only applicable to students who will be a resident in a residence where the University issues the contract (i.e. residences in The Village or The City), this will not cover private accommodation.

- Students can apply for the rent subsidy if they require an en-suite, studio or flat in University contracted accommodation due to their disability and/or health needs. The requirement for subsidy must be discussed and supported by AccessAbility.
- If you are supported by a resident carer for personal care assistant you will need to contact AccessAbility to discuss your requirements by 1st September.

The subsidy will not automatically be awarded to students with disclosed disabilities who are in an en-suite, studio or flat in University contracted accommodation; as a first year, you will need to engage with AccessAbility for assessment. If you are a returning student and wish to return to University accommodation, you will need to reengage with AccessAbility. If you require areassessment, this will form part of the process to support your accommodation application.

The subsidy will be calculated annually and will be credited to your account on a termly basis (in line with the rent payment dates).

For 2025/26 the subsidy will reduce the required room rate to the average weekly cost of a chosen halls of residence. Please see the table above for the applicable rates.

Please note that these prices are only applicable for the academic year as shown in the table. This policy and the associated prices are reviewed and updated annually.

If your application is received after the start of the contract period then the subsidy will apply on a pro-rota basis, starting from the date you requested the room subsidy

Criteria

You are eligible to apply if you meet one or more of the following criteria:

- 1. A requirement for an en-suite, studio or flat in University contracted accommodation as a result of a physical disability i.e. mobility difficulty/wheelchair user, where specific accessibility requirements prevent you from sharing bathroom facilities with others.
- 2. A requirement for an en-suite, studio or flat in University contracted accommodation as a result of a sensory disability e.g. visual impairment, that prevents you from maintaining independence when sharing bathroom facilities because other students impact on the accessibility or usability of the shared space.
- 3. A requirement for an en-suite, studio or flat in University contracted accommodation as a result of an unseen condition such as a mental health disability, autism spectrum condition or a medical condition that prevents you from using shared bathroom facilities without a substantial impact on your wellbeing and ability to carry out self-care activities.
- 4. A requirement for an additional room to be used by a carer or support worker. Please note all of our bed spaces are single occupancy (except where a flat has multiple bedrooms).
- 5. Exceptional cases where a requirement for an en-suite, studio or flat accommodation is considered appropriate by Senior Student Support Services staff, based on evidence of ongoing difficulties that substantially impact on your ability to use shared bathroom facilities.

Personal convenience or preference do not form part of the criteria and will not be considered.

Travel to campus

Designated parking spaces are available at most residences for disabled persons, parking permits are charged at an annual rate. If you require a disabled parking at the academic campus please refer to the University of Leicester Parking Policy.

The University shuttle bus service provides regular buses, during term time, from The Village to the main academic campus free of charge. This service supports wheel chair access.

Application Process

We have a specific process for you to follow should you wish to be considered for room subsidy by the University. If you meet the criteria and wish to apply, please submit your accommodation application using the University of Leicester <u>Accommodation portal</u> making note that you will be applying for the adapted rooms subsidy.

Please then contact the <u>AccessAbility team</u> and ask for support with your accommodation in line with the adapted rooms policy. The AccessAbility team will then request your supporting evidence for assessment. They will contact you about your requirements and email the Accommodation Team with their recommendation.

The Accommodation team will then review your accommodation application alongside your AccessAbility recommendations and make an offer accordingly.

All offers of accommodation are subject to availability. Should your required room type be unavailable, you will be contacted to discuss the options available to you and any reasonable adjustments that can be made.

The deadline for completion of applications to guarantee accommodation in your first year of study at the University is 1st September though we encourage the application to be submitted at the earliest opportunity.

The deadline for completion of applications under this policy for returning students is 30th June. Whilst every effort will be made for students under this policy to remain in their current accommodation, this cannot be guaranteed.
